

## **Wholesale Generation Credit Rate Payment Agreement**

Application to customer receiving service on the District's Residential and Small Commercial Rates. 1. Customer Name: \_ Customer Address: \_\_\_ LID Electric Service Account Number: \_\_\_\_\_\_\_\_ LID Electric Service Rate Code:\_\_\_ Service Address: Wholesale Generation Credit (WGC) Monthly any excess kilo-watt hour ("kwh") generated by the customer and received by LID will be calculated and credited against any current month's charges. The credits will be at the rate set by the tariff and subject to adjustment. If a customer's generation credit should be greater than the monthly charges, the excess credits will be rolled into the next month's billing. Annually, each WGC account will be reviewed. If the account has a credit balance due to excess generation credits, the customer will receive a notice to provide LID with a W-9. Upon receipt of the W-9 a check in the credit amount will be issued to the customer. **Applicability** The WGC rate is applicable to Customers owning and operating a solar electrical generation facility with a capacity of not more than 1 megawatt ("MW") at the customer premises which operates in parallel with the District's transmission and distribution facilities and is intended primarily to offset part or all of the Customer's own electrical requirements. Application of the WGC Rate is a replacement of the suspended NEM2.0. If the District reinstates the NEM2.0 rate, the customers currently on the WGC rate will be allowed to move to the NEM2.1, on a first come, first served basis. In addition to this Agreement, the Customer must sign the District's "Electrical WGC Interconnection Agreement for WGC Metering form Solar Electric Facilities of 1 Megawatt or Less (WGC Interconnection Agreement). **Metering of Wholesale Generation** WGC Energy Metering uses a non-demand, non-time differentiated meter or meters to measure the in kilowatt-hours ("kWh") the energy supplied to the District generated by the Customer. **Annualized Settlement Method** Billing and payments shall be made in accordance with the WGC Rate Schedule. **Effective Date, Modification, and Termination** The agreement shall be in effect when signed by the Customer and the District, and shall remain in effect thereafter until the Interconnection Agreement between the District and the Customer is terminated. This Agreement can only be modified or altered by a subsequent document signed by both the District and the In addition to termination of the Interconnection Agreement, this Agreement may be terminated only by mutually signed written agreement of both the Customer and the District and shall be effective the last day of the Customer's billing cycle. Rates, Rules, & Regulations This Agreement will at all times be subject to the District's Rates, Rules, and Regulations, as amended from time to time. Any changes to the District's Rates, Rules, and Regulations that would modify this Agreement shall automatically be incorporated herein without need for formal amendment. IN WITNESS WHEREOF, The Parties hereto have caused this Agreement to be executed by their duly authorized representatives. This Agreement is effective as of the last date set forth below.
